Proposal for school term dates for the academic year 2020/21: Consultation

I am writing to you as part of a consultation process to make changes to the school's term dates for 2020/21. The proposed changes, alongside the rationale for the proposal and timescales are set out below. I am keen to get your feedback before putting in place any changes for September 2020. The proposed new term dates outlined in the table below will align with the majority of Avanti's other schools and are founded on what we as professional educational leaders believe will support us in our quest to continue to raise standards in the school.
