**RE: Google Classroom**


As you know, in the case of a school closure, we will be providing your children online work. This will be for years 1-6. Reception will publish their homework via the website and continue to use EExAT as usual.

For children in years 1-6, class teachers have set up google classroom. This is where children will access their work for each day. Their work will also show a due date to indicate which tasks are due first. To access google classroom and the learning, we have created a video which we will be posted on the school website. Please follow the steps in the video which will show you how to log on, access your child's class, viewing and submitting work. The video highlights an option where your child can ask their teacher any work-related question if they have any issues.

Please look at the picture below which shows where you can find the video. You will need to go to **Pupils – Hover over the tab till you see ‘Digital Leaders’**. Please note that this video cannot be found unless you select the link which is below the picture. You will not be able to search it in the YouTube search engine.
