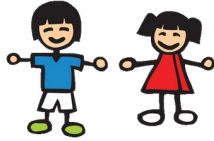
We hope you are enjoying your time with your family at home. We know it can be difficult times but you are all doing really well.

- ★ My adult can see what I am doing.
- ★ My adult has logged onto what I am using and checked it is safe and secure for me.
- ★ I use the internet for the time decided by my adult.
- ★ I know not to share anything about myself that my parents have not allowed me to.
- ★ I won't type my name, age or school anywhere without showing my adult first

KS1



- ★ My adult is aware of which webpages I am using.
- ★ I am using the device/ internet for the time given by my adult.
- ★ Only I am logged on and accessing my classwork.
- ★ Any other websites I use, my adult is aware of.
- ★ I don't share personal information like my name, school or age on any website with my adult's permission.
- ★ My adult knows which games I am playing on the internet.

KS2



- ★ My adult is aware of which webpages I am using.
- ★ My adult has access to all login details for any accounts I have. Including phones and gaming.
- ★ Only I am logged on and accessing my classwork.
- ★ Any other websites I use, my adult is aware of.
- ★ I don't use my real name for any accounts that are for playing games.
- ★ I don't share personal information like my name, school or age on any website without my adult's permission.

Why do we have these rules?



1. **It isn't a punishment**

We don't have these rules to be strict or punish you. This is to protect you from any danger in the digital world. Just like in the real world, you may be told not to talk to strangers, it is the same for the digital world.

2. **We know how to help if a situation comes up**

For your trusted adult to know your details and knowing what you use, if a situation was to occur, they know how to help and protect you. You would not need to be worried and scared as you are using the internet/ devices with honesty and integrity with your adults.

3. **Increasing our understanding and knowledge**

You become more aware of what could happen or go wrong if you don't follow such rules. Knowing the dangers is important for you to become aware of how to do the right thing. You are then in a position to help and support your family, friends and other people when using the internet and other technology.
