Google Classroom

The school will be disabling all children's access to GC from Saturday 4th July to Wednesday 8th July 2020. We will be deleting existing passwords and allocating new/unique passwords. The new details will be emailed to you, parents, so that children and staff can resume using GC from Thursday 9th July 2020. Staff will upload a project, on the school website, for children to complete.

On the last three Fridays of the term; Friday 10th, 17th and Friday 24th July, staff will not be available to check/provide marking and feedback to work submitted on GC. These days have been allocated to all staff to begin to organise their classrooms in readiness for the next academic year, the last day of term being Thursday 23rd July 2020.

Summer Home Learning

Teachers will upload home learning via GC which will be accessible from Friday 24th July. Watch this space for more information.

Children's exercise books

Children's current books will follow them to the next year group, where they will carry on using them. Any old exercise books will be given to children to take home, in the Autumn term.

Exercise books of children in Year 6 will be given out, to the children in school, before the end of term. For children who are not attending school, books can be collected in September.
