

# Pupil premium strategy statement – Avanti Park School Review 2024

# Part A: Pupil premium strategy plan

## Statement of intent

At Avanti Park School, our vision is to help pupils, regardless of their socio-economic circumstances, become well-rounded human-beings through intellectual, moral and spiritual growth, and so make the world a better place.

Our aim is to use the pupil premium funding to counter disadvantage and ensure greater equity through:

- Ensuring excellent teaching for all pupils
- Providing targeted academic support
- Using wider strategies including work with parents and carers

### **Ensuring excellent teaching for all pupils**

At Avanti Park School, we believe that all learners are entitled to an education that equips them with the knowledge, skills and values they need and teaches them how they can contribute to a future they want to live in.

Quality first teaching is vital in achieving this and in diminishing the gap between disadvantaged and non-disadvantaged pupils. We are committed to raising the standard of teaching and learning through an evidence-based approach; all teaching staff receive extensive continuous professional development.

### **Providing targeted academic support**

For some children, quality first teaching may not be enough and there is a need for additional targeted academic support. Class teachers use assessment to track and monitor the progress of pupils and hold termly pupil progress meetings with a member of the senior leadership team to discuss strategies and early intervention requirements to address any gaps in learning.

### **Using wider strategies including work with parents and carers**

In addition to academic support, we use a range of wider strategies to contribute to success in school including:

- Effective lines of communication between home and school
- A focus on improving attendance and punctuality
- Support for wellbeing and mental-health
- Workshops for parents
- Curriculum enrichment opportunities

- Support with the cost of school supplies including uniform

Our approach is responsive to robust data analysis and not driven by assumptions. A combination of the approaches outlined above will complement one another to help all pupils excel.

## Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	<p><b>Gaps in reading</b> – internal and external assessments indicate that the disadvantaged pupils have greater difficulties in acquiring phonic knowledge than their peers.</p> <p>It is also evident that there are gaps in comprehension, especially knowledge of vocabulary, which negatively impacts their development as readers.</p> <p>In Reception, 100% of pupil premium eligible children achieved age-related expectations (ARE) in literacy (comprehension), whereas 92.8% of non-pupil premium eligible children met ARE.</p> <p>In KS1, 75% of pupil premium (PP) eligible children met ARE at the end of KS1 in 2022, whereas 87% of non-pupil premium eligible children met ARE.</p> <p>100% of pupil premium (PP) eligible children in year 1 passed the phonics screening check last academic year (2023-2024), outperforming non-PP eligible children of whom 94.5% passed the phonics screening check.</p> <p>In KS2, 64% of PP eligible children met ARE whereas, 79% of non-PP eligible met ARE.</p>
2	<p><b>Gaps in writing</b> – writing attainment in disadvantaged pupils is below that of non-disadvantaged.</p> <p>In KS1, 25% of PP eligible children met ARE whereas 74% of non-PP children met ARE.</p> <p>In KS2, 63% of PP eligible children achieved ARE, whereas 83% of non-PP met ARE.</p>
3	<p><b>Gaps in maths</b> – maths attainment for disadvantaged children track below their non-disadvantaged peers across most key stages.</p> <p>In Reception, 100% of the disadvantaged pupils met the expected standard in number whereas, 87.93% met the standard in non-disadvantaged in 2024.</p> <p>In KS1, 63% of PP eligible met ARE whereas, 83% of non-PP met ARE.</p>

	In KS2 50% of PP eligible met ARE whereas, 60% of non-PP met ARE.
4	<b>Wellbeing and emotional needs</b> – our observations, including conversations with families, have identified wellbeing and emotional issues for many pupils. This has resulted in knowledge gaps leading to pupils falling further behind. Teacher referrals for support remain relatively high; 65% of our pupils receiving additional support for social and emotional needs and small group interventions are pupil premium eligible.
5	<b>Enrichment opportunities</b> – A large proportion of our PP eligible families want to access extra-curricular activities but require some support to be able to do this.
6	<b>Attendance concerns</b> - our attendance data over the last year (September 2023 to August 2024) indicates that attendance among disadvantaged pupils is 5.8% lower than for non-disadvantaged pupils.  Persistent absence among disadvantaged pupils is 21.9% higher than for non-disadvantaged pupils: 36.1% of disadvantaged pupils have been 'persistently absent' last academic year, compared to 14.2% of their peers.  Our assessments and observations indicate that absenteeism is negatively impacting disadvantaged pupils' progress.
7	<b>Financial issues</b> – our relationships with families reveal the hardships that some are placed under - unable to purchase new, correctly fitting uniforms which is affecting attendance and therefore attainment.

## Part B: Review of the previous academic year

### Outcomes for disadvantaged pupils

We have analysed the academic performance of our school's disadvantaged pupils during the 2023/24 academic year using key stage 1 and 2 SATs data, phonics check results and our internal data.

#### **Phonics – pupil premium eligible**

60% passed the phonics screening test in 21/22 which increased to 100% in 23/24 (68% national)

#### **KS1 results – pupil premium eligible**

Reading: 54% ARE in 22/23 to 75% ARE in 23/24

Writing: 44% ARE in 22/23 to 25% ARE in 23/24

Maths: 56% ARE in 22/23 to 63% ARE in 23/24

#### **KS2 results – pupil premium eligible**

Reading: 56% ARE in 22/23 to 64% at ARE in 23/24

Maths: 38% ARE in 22/23 to 50% ARE in 23/24.

Writing: 38% ARE in 22/23 to 71% ARE in 23/24

There continues to be a gap between the disadvantaged children and non-disadvantaged children which is reflected in the national picture. However, we have seen an impact on the results of all children following the strategies outlined and, although there continues to be work to be done in order for our results to be in line with national figures, there is an upward trend across the last three years.

Phonics results have improved significantly: our most recent data shows 100% of PP children passing the phonics screening check, outperforming our non PP children.

Our analysis suggests that the reason that our PP data for RWM continues to be below national figures in KS1 is due to lower than expected attainment in writing. Whilst PP children performed above national expectations in reading and maths, the teaching and moderation of writing within KS1 has not been delivered as effectively as we would have liked. This is due to mid-year staffing challenges within the phase.

In KS2 we continue to track below combined national figures, and this is primarily due to a lower than expected performance in maths. Historically, maths results have been

the weakest of the core subjects and whilst we have worked hard to close gaps – and continued to make year on year improvements – we still track below national figures.

We have also had significant movement of pupils with only 33.2% of our children having started in Reception; over 160 families have joined since September 22 from neighbouring schools or elected home education, and we continue to take in-year admissions. This year we have had a further 31 in-year admissions. This is due to our ever-improving reputation within the community; however, this has meant we have had limited time to close gaps and have an impact on some children's knowledge and understanding before their first formal assessments.

### **Excellent Teaching**

The investment in improving teaching and learning from the Ambition Institute has had a positive impact. Our data from learning walks show there is consistently good or exceptional teaching and learning across the school and leaders now have a shared understanding and language around what effective, quality first teaching looks like.

The early reading lead has had a positive impact on the phonics screening results in KS1 with our figures now above national figures and PP children achieving a 100% pass rate. This is promising data and signifies that with robust phonics teaching all children have a better chance at success.

A new resource has been put in place since September 2022 (CUSP Unity Schools) to teach the National Curriculum. This has provided quality, ambitious resources, including a rich literature spine, to support the learning of all children.

### **Targeted support**

Small group and 1:1 tuition proves to be successful when implemented carefully and focussed on the specific gaps of our children. The senior leadership team work with class teachers to ensure that additional adults are used effectively. Changes in support staff, staff absence and over 107 school admissions during 2023/2024 impacted the effectiveness of some interventions and therefore targeted academic support remains a key part of our strategy.

### **Wider strategies**

Absence among disadvantaged pupils remained at 4% higher than their peers in 23/24 and 1% lower than national figures.

Persistent absence is still higher for disadvantaged children by 16% in 23/24 and higher also than national figures by 7.5%.

We understand the continued need for strategies to be in place to address absenteeism and why raising attendance for all children is still a focus of our current plan.

We plan to address parents' misconceptions around attendance including how important social time and interactions are at this stage of development. We will provide accurate information about how their child is attending in comparison to their peers. We will meet weekly as SLT to discuss attendance and celebrate those that have shown improvements.

Pupil Premium Champions this year supported disadvantaged children who also have lower than 90% attendance. Each child was paired with a member of staff who met them each term, building a relationship with them, and providing social and emotional support over the year.

All pupil premium children have been able to attend an overnight residential between Year 5 and Year 8 fully funded. 36% of the children attending an overnight stay in 23/24 were fully funded.

Offering subsidised club opportunities for PP-eligible children has meant that the number of PP-eligible children accessing clubs has increased by 26% since the start of this strategy in 21/22. We will continue to offer and subsidise a range of enrichment opportunities for eligible children.

#### **Behaviour incidences**

51% of all recorded behaviour incidences in 21/22 were by PP eligible children.

34% of all recorded behaviour incidences in 22/23 were by PP eligible children.

31% of all recorded behaviour incidences in 23/24 were by PP eligible children.

This is a reduction and going in the right direction but not at our target of 19%.

Our analysis means that we have made changes to how we intend to use our budget this academic year, as set out in the 'Activity in This Academic Year' section above.

### **Planning, implementation, and evaluation**

In planning our new pupil premium strategy for 2022/2023, we evaluated why activity undertaken in previous years had not had the degree of impact that we had expected and we commissioned a pupil premium review to get an external perspective. The new deputy principal, leading on pupil premium, has attended professional development with the advisor for improving outcomes for disadvantaged pupils for the Unity Schools Partnership, Marc Rowland, which has enabled us to put in place a more effective strategy for the coming years.

We have used the advice from the review, the work with Marc Rowland and the research provided from the EEF to help us to design an implementation strategy which will have the most impact on our pupils.

We will continue to use the EEFs implementation guidance to support us to evaluate the approach and adjust our plan to secure better outcomes for all our pupils.
