### **Statement of intent**

A school which is part of the Avanti Schools Trust, our intention is to provide quality first teaching and learning through developing educational excellence, character development and spiritual insight.

Our aim is for no child to be left behind due to disadvantage. We strive to remove low expectations, raise lifelong aspirations and focus on removing barriers to learning and achieve excellence so that our pupils become well-rounded human beings through intellectual, moral and spiritual growth, and so make the world a better place.

Our plan aims to address the main barriers our children face and through rigorous tracking, careful planning and targeted support and intervention, provide all children with access to enrichment and cultural opportunities and to enjoy academic success and personal growth through targeted interventions.

#### Challenges

1	To develop early identification and early intervention using a SaLTA/SaLT for EYFS/Y1/Y2 (WellComm screening and Love to Communicate)
2	To continue to invest in the arts through enrichment activities for all children. Uniform subsidies
3	To continue to develop children's reading for pleasure by developing special class reading boxes
4	To develop oracy and improved vocabulary by developing children's speaking, listening and by developing reading fluency across the school.
5	Interventions led by TAs for those who are most vulnerable and on the fringe.
6	Attendance – above national for 2023/24 but to continue to have a whole school focus on this area to reduce the number of persistent and unauthorised absences.

EWO	Raised attendance and punctuality will ensure that children's attendance at school is a priority and so learning can be accessed. This will help to bring about an improvement in the schools level of attendance and to reduce unauthorised absences. The school's EWO provides regular audits of attendance, input and support when there are concerns about a pupil's level of attendance. Therefore, greater engagement from 'harder to reach families' will improve punctuality and attendance.	6
Enrichment opportunities	Wider cultural and enrichment experiences. Curriculum is broadened to include exciting links, increasing pupil engagement and excitement, including access to educational visits as well as wider experiences such as the arts, sports and workshops.	2
