Dear Parents and Carers,

Re: Schools opening on March 8th 2021

I am sure you were all eagerly waiting to hear our Prime Minister's statement regarding the lifting of the current lock down restrictions. We are delighted with the announcement and have been working towards reopening our school for Monday 8th March. My leadership team and I have already planned the finer details around drop off and pick up implications including ensuring break times and lunch times are effective. We have also placed thought on the curriculum in readiness for children returning to school, we will share these plans with you as soon as we have finalised them.



With your support, we are so proud of how independent our children have become over the last year, particularly our younger children. They have shown resilience and courage, predominantly when saying goodbye to their parents/carers in the morning, however we do understand that the long period of home learning may have left children a little anxious and perhaps reluctant to leave their families, therefore if you would like to walk your child into school, please see the table, in the attached reopening document, as to where you will be asked to say goodbye to your child. We have put this in place to firstly support you and our children in

making this transition stress free but also ensuring we are minimising the risk of spreading the virus by minimising the number of adults we have on site.

We look forward to seeing our all of our children back in school very soon, definitely something to look forward to.

I would like to thank you again for the positive manner with which you have approached remote learning since the beginning of this period of lockdown, it certainly has been difficult for many. My team and I absolutely understand how difficult home learning can be and with your support and enthusiasm our children have continued to shine and make progress.

Week beginning 1st March 2021

To ensure that staff have enough time to prepare their classrooms and organise learning resources, teachers will continue to provide remote teaching and learning in the morning, as per usual, however for the afternoon session, teachers will upload learning materials and instructions as well as complete the afternoon register, they will then log off so that they can come into school to prepare. Learning that is uploaded onto GC in the afternoon will be marked the following morning.
